The Alabama Department of Economic and Community Affairs (ADECA) is accepting applications from municipal governments for Program Year 2020 Community Development Block Grant (CDBG) funds made available through the United States Department of Housing and Urban Development (HUD). NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: The City Council of City of Foley authorizes the submission of a grant application to ADECA requesting \$250,000 in PY 2020 Community Enhancement CDBG Funds by Grant Management LLC.

SECTION 2: The City of Foley agrees to provide \$25,000 or 10% in cash matching contributions toward the project, for a total project cost of \$275,000.

SECTION 3: City Council authorizes the Mayor to sign all required grant application documents on behalf of the City.

SECTION 4: This Resolution shall become effective immediately upon its adoption as required by law.
