DESCRIPTION OF TOPIC: (who, what, when, where, why, and how much)

Bids for the **Mel Roberts** Park Pavilion/Bathroom project were originally opened on November 19th, 2020 with one bidder coming in over budget. All bids were rejected. The project was rebid and those bids were opened on January 28, 2021. There were two bidders EJ Builders and Anchor Engineering. Both bids were over the \$100,000 originally budgeted for this project and rejected. We currently have \$94,274 allocated to the project and are requesting an addition of \$85,726 are requesting to go to bid with an increased total budget of \$180,000.
