SECTION 1: Approves terminating the Alabama Festival of Flavor Performance Contract under Contracts for Public Purpose Account #100-1010-6111 for a reduction of \$20,000.

SECTION 2: Approves entering into a new performance contract with the The South Baldwin Chamber of Commerce in support of the Chicago Street Supper Club in the amount of \$\_\_\_\_\_ and appropriates funds to 100-1010-6111.
