NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Rescinds Resolution No. 19-1048-RES approving Volkert Inc.'s Supplemental Agreement No. 4 in the amount of \$70,441.

SECTION 2: Approves Volkert Inc.'s Supplemental Agreement No. 4 (REVISED) in the amount of \$98,078.56 for the design, bid and construction administration and observation for the rehabilitation of access taxiways.

SECTION 3: Approves Volkert going to bid on this project.

SECTION 4: Appropriates \$98,078.56 to account number 400-1070-5104 R46 PROF.

SECTION 5: This Resolution shall become effective immediately upon its adoption as required by law.
