A Resolution Accepting the Award for FY2019 Alabama Historical Commission's Historic Preservation Funds Grant

Council granted permission to the Community Development Department to apply for the FY2019 Alabama Historical Commission's Historic Preservation Funds Grant on RES 19-1084. The Alabama Historical Commission has awarded a grant of \$5,000 with a 40% cash/in kind match of \$3,333. These funds will be used to expand the downtown walking tours, increase historical signage along the route, and update the current walking tour brochure. CDD requests the following accounts be amended: increase to account #100-2034-4100 (Alabama Historic Commission Grants) in the amount of \$5,000 & increase to account #100-2034-6026 (Historic Commission Grant Expense) in the amount of \$8,333.
