WHEREAS, these camera systems had an original purchase price of approximately \$6000. The camera systems will be donated to Summerdale Police Department and Summerdale will pay any costs for the removal of the equipment from the vehicles.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Approves the request to declare these seven (7) Watchguard camera systems as surplus and be donated to Summerdale Police Department.
