SECTION 1: Authorizes the filling of a vacancy created by retirement in the Sanitation Department for the budgeted position of Sanitation Worker III/Driver Operator.

SECTION 2: Authorizes the filling of a vacancy created by promotion in the Sanitation Department for the budgeted position of Sanitation Worker II.

SECTION 3: Authorizes the filling of a vacancy created by promotion in the General Government/HR Division for the budgeted position of Human Resources Specialist.

SECTION 4: All action in this resolution is budget neutral.

SECTION 5: This Resolution shall become effective immediately upon its adoption as required by law.
