A Resolution Accepting Unbudgeted Donations from Several Sources to the Foley Fire Department

The Fire Department has received generous donations this fiscal year from several sources wishing to provide funding for additional equipment. We have identified a need for a battery powered ventilation fan. We are requesting that our Fire Department Donation account 100-2020-4651 be amended to reflect the unbudgeted \$3851 and our Small Tools account 100-2020-6053 be amended to show an additional \$3851, for a net effect of \$0.
